SUBJECT—Addition/Alteration/Revision of Rates.

No. 1151—FA-eOffice/2024—The Board of Paradip Port Authority vide Agenda Item No. 04(02)/2024-25 and Resolution No. 39/2024-25 approved the rates recommended by the SOR Committee. The copy of the addition/alteration/revision of rates are enclosed. The revision will be effective after expiry of 30 days from the date of notification in the State Gazette.

ADDITION/ALTERNATION/REVISION OF RATES:

- 1) Clause 4.15: The charges of handling through IOHP-MCHP connectivity system, would be Rs.70.94 per MT.
- 2) Clause 4.17: Renamed as 'The charge of handling through IOHP-MCHP connectivity system for ECL/CCL cargo'.
- 3) Clause 3.4 (6): A new sub section 6.1 is to be added under section 6  
 6.1 (i) Movement of vessel upto 30 mtrs without Pilot and Tug boat is considered as Warping.  
 (ii) If Tugs are used for warping, Tug charges will be levied in addition to warping.  
 (iii) Movement of vessel with Pilot (with/without Tug boat) is considered as Shifting.  
 (iv) Engagement of Pilot is compulsory for movement of vessel more than 30 mtrs, hence the same will be considered as Shifting.
- 4) Clause 3.4: To encourage more cape vessel calls to PPA, a new telescopic slab rate is proposed to be introduced in the Pilotage and Towage. PPA has adequate infrastructure facility to handle cape size vessel and intends to handle more cape size vessels. To attract more cape size vessel calls to PPA, it is proposed amend the 3rd slab and introduce new 4th slab with a reduction of 40% and 50% on the unit rate of the 1st slab.

- 5) Clause 2.1: To fix Barging (loading and unloading) for foreign @ Rs.23.32 per MT (Ref. Clause 2.1, Wharfage category: Others)

The SOR contains coastal rate @ 13.99 per MT for Barging and there is no rate for foreign. The coastal rates are levied at a discount of 40% of the foreign rates in the SOR. In this context, the foreign rate would be Rs.23.32 per MT.

- 6) Clause 4.9: A fee of Rs.2/- per tonneto be levied on the cargo transloaded from/to the mother vessel at the Transloadingpoint under the limits of PPA.

- 7) Clause 4.19: To charge Rs.2/- per Tonne as Facilitation fee for loading of barge at IFFCO Pantoon jetty.

- 8) Clause 4.20: STS Charges

The following rates for STS operation and floaters:

1) Floaters- Not to levy any charges

N.B.:

- The charges includes Tug charges for 1 mooring and 1 un-mooring operation, Port dues, Pilotage, Wharfage and all other applicable charges.
- The count of STS includes both STS operation at Anchorage and STS at NOJ.
- Anchorage charges as applicable will be levied.
